

MINUTES OF THE MEETING

A meeting of the Board of Trustees of Sanitary and Improvement District No. 7 of Platte County, Nebraska, was convened in accordance with Executive Order No. 20-03 at 9:00 a.m. on Monday, July 27, 2020, via secured conference call due to COVID-19 restrictions. Trustees present at the meeting were: Bill Rongisch, Stephen Stevens, Tom Goc, and Jim Boesch. Trustees Absent: Jay Marxsen. Other interested parties present: Jenny Reppert, Platte County Treasurer; Adam Elm, Accountant for Schumacher, Smejkal, Brockhaus & Herley, P.C, Mark Fitzgerald, Attorney for Fitzgerald, Vetter, Temple & Bartell; and Shelia Cermak.

Notice of the meeting was given in advance thereof by publication in the *Columbus Telegram* on July 22, 2020, a copy of the Proof of Publication being attached to these minutes. The availability of the Agenda was communicated in the published notice and in the Notice to the Trustees of this meeting. All of the subjects addressed at this meeting were contained in the Agenda for at least 24 hours prior to the meeting, which Agenda was kept continually current and readily available for public inspection at the address listed in the meeting notice. All proceedings of the Board were taken while the convened meeting was open to the attendance of the public. A current copy of the Nebraska Open Meetings Act was available and accessible to members of the public, posted during the meeting in the meeting area and all in attendance at the meeting were informed of the location of such copy. At least one copy of all resolutions and other reproducible written materials, for which actions are shown in said proceedings, was made available for examination and copying by members of the public at the meeting.

Following roll call, the Chairman directed the Board's attention to Item No. 2 on the agenda, pertaining to discussion and approval of the April 1, 2020 meeting minutes. After a full discussion, the following resolution was moved by Trustee Goc and seconded by Trustee Stevens, to-wit:

BE IT RESOLVED, that the Board of Trustees of Sanitary and Improvement
District No. 7 of Platte County, Nebraska approve the April 1, 2020 meeting minutes.

On roll call for the foregoing resolution, the following Trustees voted Aye: Rongisch, Stevens, Goc, and Boesch. Voting Nay thereon were the following Trustees: None. Trustees absent: Marxsen. The Chairman then declared said resolution was duly carried and adopted.

The Chairman then directed the Board's attention to Item No. 3 on the agenda, pertaining to discussion of a District taxpayer's inclusion in the District. Discussion was held regarding the taxpayer's inclusion in the District. No action was taken at this time.

The Chairman then directed the Board's attention to Item No. 4 on the agenda, pertaining to discussion and financial review of the District's accounts. Discussion was held regarding the financial state of the District. No action was taken at this time.

The Chairman then directed the Board's attention to Item No. 5 on the agenda, pertaining to discussion on short term loan attainment process. After a full discussion, the following resolutions were moved by Trustee Stevens and seconded by Trustee Goc, to-wit:

BE IT RESOLVED, by the Board of Trustees of Sanitary and Improvement District No. 7 of Platte County, Nebraska, that the Chairman and Clerk be, and they hereby are, authorized and directed to execute and deliver Eight (8) **General Fund** Warrants in the sum of Twenty-Five Thousand and 00/100's (\$25,000.00) each, totaling Two-Hundred Thousand and 00/100's Dollars (\$200,000.00), to be dated and registered upon approval of the levee reconstruction engineer, and to draw interest at a rate of 4% per annum from date of registration until paid.

BE IT FURTHER RESOLVED, by the Board of Trustees of Sanitary and Improvement District No. 7 of Platte County, Nebraska, that both they and the District hereby find and determine and covenant, warrant and agree as follows: the improvements and/or facilities being financed or refinanced by the above General Fund Warrants are for essential governmental functions and are designed to serve members of the general public on an equal basis; all said improvements have from the time of their first acquisition and construction been owned, are owned and are to be owned by the District or another political subdivision; to the extent special assessments have been or are to be levied for any of said improvements, such special assessments have been or are to be levied under Nebraska law as a matter of general application to all property specially benefitted by said improvement in the District; the development of the land in the District is for residential or commercial use and the development of the land in the District for sale and occupation by the general public has proceeded and is proceeding with reasonable speed; other than any incidental use of said improvement by a developer during the initial period of development of said improvements, there have been, are and will be no persons with rights to use such improvements other than as members of the general public; none of the proceeds of said Bonds or any refinanced indebtedness have been or will be loaned to any private person or entity; the District hereby authorizes and directs the Chairperson or Clerk to file or cause to be filed, when due, an information reporting form pursuant to Section 149 (e) of the Internal Revenue Code of 1986, as amended, pertaining to the above Warrants; and the District does not reasonably expect to sell or otherwise dispose of said improvements and/or facilities, in whole or in part, prior to the last maturity of the above Warrants.

BE IT FURTHER RESOLVED, by the Board of Trustees of Sanitary and Improvement District No. 7 of Platte County, Nebraska that the District hereby covenants, warrants and agrees as follows: (a) to take all actions necessary under current federal law to maintain the tax exempt status (as to taxpayers generally) of interest on the above Warrants; and (b) to the extent that it may lawfully do so, the District hereby designated the above Warrants as its "qualified tax exempt obligations" under Section 265(b)(3)(B)(i)(III) of the Internal Revenue Code of 1986 as amended and covenants and warrants that the District does not reasonably expect to issue warrants or bonds or other

obligations aggregating in the principal amount of more than \$5,000,000 during the calendar year in which the above Warrants are to be issued.

BE IT FURTHER RESOLVED, by the Board of Trustees of Sanitary and Improvement District No. 7 of Platte County, Nebraska that this and the preceding Resolutions are hereby adopted as the Certificate with Respect to Arbitrage of the District pertaining to the above Warrants and the District and the Chairperson and Clerk of the District hereby further certify, as of the date of the resignation of the above Warrants with the County Treasurer of Platte County, Nebraska, as follows:

1. No separate reserve or replacement fund has been or will be established with respect to the above Warrants. The District reasonably anticipates that monies in its General Fund reasonably attributable to the above Warrants in excess of the lesser of: (a) 10% of the net principal proceeds of the above Warrants, (b) the maximum annual debt service due on the above Warrants, or (c) 125% of average annual debt service due on the above Warrants will be expended for payment of principal of and interest on the above Warrants within 13 months after receipt of such monies. That amount which is currently held in the District's General Fund which exceeds the amount which is to be expended for payment of principal and interest on the above Warrants within 13 months after receipt of such monies, plus that amount arrived at pursuant to the immediately preceding sentence, will not be invested in any securities or any other investment obligations which bear a yield, as computed in accordance with the actuarial method, in excess of the yield on the above Warrants.
2. To the best of their knowledge, information and belief, the above expectations are reasonable.
3. The District has not been notified of any listing of it by the Internal Revenue Service as an issuer that may not certify its bonds.
4. This Certificate is being passed, executed and delivered pursuant to Section 1.148-2(b)(2) of the Income Tax Regulations under the Internal Revenue Code of 1986, as amended.

On roll call for the foregoing resolutions, the following Trustees voted Aye: Rongisch, Stevens, Goc, and Boesch. Voting Nay thereon were the following Trustees: None. Trustees absent: Marxsen. The Chairman then declared said resolution was duly carried and adopted.

BE IT RESOLVED, that the Board of Trustees of Sanitary and Improvement District No. 7 of Platte County, Nebraska, that the Chairman and Clerk be, and they hereby are, authorized and directed to execute and deliver **General Fund** Warrant Nos. 539-545 dated today's date, to the following payees and in the following amounts:

- A. General Fund Warrant No. 539 in the sum of One Thousand Four Hundred Fifty and 00/100's Dollars (\$1,450.00), payable to Koot's Snow Removal for payment of snow removal services.
- B. General Fund Warrant No. 540 in the sum of Seven Thousand One Hundred Sixty-Two and 00/100's Dollars (\$7,162.00), payable to Schumacher, Smejkal, Brockhaus & Herley, P.C. for payment of bookkeeping and professional services.
- C. General Fund Warrant No. 541 in the sum of Four Hundred Sixty-Five and 00/100's Dollars (\$465.00), payable to 10 County Title & Escrow, Inc. for payment of legal services.
- D. General Fund Warrant No. 542 in the sum of One Thousand Nine Hundred Fifty-Seven and 92/100's Dollars (\$1,957.92), payable to Advanced Consulting Engineering Services for payment of engineering services for the District's levee reconstruction project.

BE IT RESOLVED, that the Board of Trustees of Sanitary and Improvement District No. 7 of Platte County, Nebraska, pre-approve payment for services to the following payees and in the following amounts from the following funds:

- A. **Sewer Force Main Replacement Fund** in the sum of Twenty-Four Thousand Four Hundred Seventy-Six and 91/100's Dollars (\$24,476.91), payable to the NDEQ for payment of semi-annual interest and principal payment on loan #C317980 due December 15, 2020.
- B. **General Fund** not to exceed the sum of One Thousand Four Hundred Ninety-Six and 00/100's Dollars (\$1,496.00), payable to LARM for payment of insurance services.

On roll call for the foregoing resolution, the following Trustees voted Aye: Rongisch, Stevens, Goc, and Boesch. Voting Nay thereon were the following Trustees: None. Trustees absent: Marxsen. The Chairman then declared said resolution was duly carried and adopted.

BE IT RESOLVED, that the Board of Trustees of Sanitary and Improvement District No. 7 of Platte County, Nebraska, pre-approve payment for services to the following payee and in the following amount from the **General Fund**, contingent on approval from the levee reconstruction engineer:

- A. Not to exceed Two-Hundred Thousand and 00/100's Dollars (\$200,000.00), payable to Johnson Sand & Gravel for payment of levee reconstruction services.

On roll call for the foregoing resolution, the following Trustees voted Aye: Rongisch, Stevens, Goc, and Boesch. Voting Nay thereon were the following Trustees: None. Trustees absent: Marxsen. The Chairman then declared said resolution was duly carried and adopted.

The Chairman then directed the Board's attention to Item No. 8 on the agenda, pertaining to discussion of levee reconstruction. Discussion was held regarding the levee reconstruction. No action was taken at this time.

The Chairman then directed the Board's attention to Item No. 9 on the agenda, pertaining to discussion of LLNRD. Discussion was held regarding the LLNRD. No action was taken at this time.






