A meeting of the Board of Trustees of Sanitary and Improvement District No. 7 of Platte County, Nebraska, was convened in accordance with Executive Order No. 20-03 at 9:00 a.m. on Wednesday, April 1, 2020, at the office of Schumacher, Smejkal, Brockhaus & Herley, P.C. at 3403 27th Street, Columbus, Nebraska. Trustees present at the meeting were: Bill Rongisch, Stephen Stevens, Jay Marxsen, Tom Goc, and Jim Boesch. Trustees Absent: None. Other interested parties present: Jenny Reppert, Platte County Treasurer; Adam Elm, Accountant for Schumacher, Smejkal, Brockhaus & Herley, P.C, Mark Fitzgerald, Attorney for Fitzgerald, Vetter, Temple & Bartell and John Zwingman.

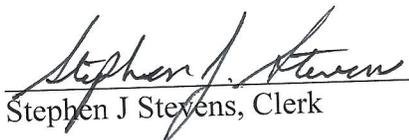

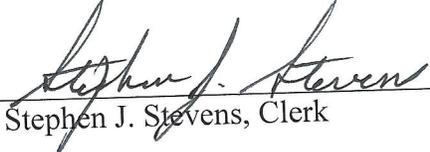

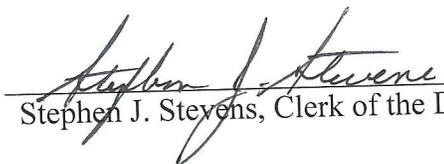
