Trustees present at the meeting were: Jerome Slusarski, Doug Brackhan, Aaron Kosch, and Christopher Hutchinson. Trustees Absent: Kevin McCright. Other interested parties present: none.

Notice of the meeting was given in advance thereof by publication in the *Columbus Telegram* on April 11, 2023, a copy of the Proof of Publication being attached to these minutes. The availability of the Agenda was communicated in the published notice and in the Notice to the Trustees of this meeting. All of the subjects addressed at this meeting were contained in the Agenda for at least 24 hours prior to the meeting, which Agenda was kept continually current and readily available for public inspection at the address listed in the meeting notice. Trustee Slusarski and Trustee McCright were asked to review the levee maintenance manuals for inspection and documentation requirements and to perform the exercises at a convenient date.

The Chairman then directed the Board's attention to Item No. 10 on the agenda, pertaining to the project to resurface the top of the southeast section of the levee where excess sand has blown in. After a full discussion, the following resolution was moved by Trustee Kosch and seconded by Trustee Slusarski, to-wit:

BE IT RESOLVED, that the Board of Trustees of Sanitary and Improvement District No. 7 of Platte County, Nebraska, approve hiring a civil engineer to give guidance in southeast levee project and to oversee the project if necessary.

Discuss was had on how to prevent issue in the future and to explain to Dale Johnson to be careful. After a full discussion, the following resolution was moved by Trustee Kosch and seconded by Trustee Slusarski, to-wit:

BE IT RESOLVED, that the Board of Trustees of Sanitary and Improvement District No. 7 of Platte County, Nebraska pre-approve payments up to Six Thousand and 00/100's Dollars (\$6,000.00) for repairing the storm drain in Eagle Lane.

The Chairman then directed the Board's attention to Item No. 14 on the agenda, pertaining to miscellaneous comments. Trustee Brackhan brought up that elections are in September. Trustee Kosch and Hutchinson are looking to get off but will continue.

There being no further business to come before the meeting, a motion for adjournment was duly moved by Trustee Hutchinson and seconded by Trustee Kosch, and unanimously carried. The meeting was adjourned at 10:45 a.m.
