

MINUTES OF THE MEETING
OF
SANITARY AND IMPROVEMENT DISTRICT NO. 7
OF
PLATTE COUNTY, NEBRASKA

A meeting of the Board of Trustees of Sanitary and Improvement District No. 7 of Platte County, Nebraska, was convened in open and public session at 9:00 a.m. on Wednesday, October 16, 2019, at the office of Schumacher, Smejkal, Brockhaus & Herley, P.C. at 3403 27th Street, Columbus, Nebraska. Trustees present at the meeting were: Bill Rongisch, Stephen Stevens, Jay Marxsen, and Jim Boesch. Trustees Absent: Tom Goc. Other interested parties present: Adam Elm, Accountant for Schumacher, Smejkal, Brockhaus & Herley, P.C.

Notice of the meeting was given in advance thereof by publication in the *Columbus Telegram* on October 11, 2019, a copy of the Proof of Publication being attached to these minutes. The availability of the Agenda was communicated in the published notice and in the Notice to the Trustees of this meeting. All of the subjects addressed at this meeting were contained in the Agenda for at least 24 hours prior to the meeting, which Agenda was kept continually current and readily available for public inspection at the address listed in the meeting notice. All proceedings of the Board were taken while the convened meeting was open to the attendance of the public. A current copy of the Nebraska Open Meetings Act was available and accessible to members of the public, posted during the meeting in the meeting area and all in attendance at the meeting were informed of the location of such copy. At least one copy of all resolutions and other reproducible written materials, for which actions are shown in said proceedings, was made available for examination and copying by members of the public at the meeting.

The undersigned Clerk hereby certifies that these minutes were written and available for public inspection within ten (10) working days after the date of said meeting.

Following roll call, the Chairman directed the Board's attention to Item No. 2 on the agenda, pertaining to discussion and approval of the September 4, 2019 meeting minutes. After a full discussion, the following resolution was moved by Trustee Marxsen and seconded by Trustee Boesch, to-wit:

BE IT RESOLVED, that the Board of Trustees of Sanitary and Improvement District No. 7 of Platte County, Nebraska approve the September 4, 2019 meeting minutes.

On roll call for the foregoing resolution, the following Trustees voted Aye: Rongisch, Marxsen, Stevens, and Boesch. Voting Nay thereon were the following Trustees: None. Trustees absent: Goc. The Chairman then declared said resolution was duly carried and adopted.

Trustee Goc entered the meeting at 9:06 a.m.

The Chairman then directed the Board's attention to Item No. 3 on the agenda, pertaining to discussion and approval of a bid to repair the levee erosion caused by the March 2019 flood. After a full discussion, the following resolution was moved by Trustee Stevens and seconded by Trustee Goc, to-wit:

BE IT RESOLVED, that the Board of Trustees of Sanitary and Improvement District No. 7 of Platte County, Nebraska approve the bid from Johnson Trucking to repair the levee erosion in the amount of \$175,059.

On roll call for the foregoing resolution, the following Trustees voted Aye: Rongisch, Marxsen, Stevens, Goc, and Boesch. Voting Nay thereon were the following Trustees: None. The Chairman then declared said resolution was duly carried and adopted.

The Chairman then directed the Board's attention to Item No. 4 on the agenda, pertaining to discussion and financial review of the District's accounts. The Board discussed the need for short-term financing to pay for the levee erosion project, that being the District's No. 1 priority. The Board then discussed their No. 2 priority of long term financing through the redemption of bonds. After a full discussion, the following resolutions were moved by Trustee Stevens and seconded by Trustee Goc, to-wit:

BE IT RESOLVED that the Board of Trustees of Sanitary and Improvement District No. 7 of Platte County, Nebraska, approve the redemption of **Construction Fund #1** Warrant Nos. 654-658 as of October 31, 2019 in Nine Thousand Three Hundred Ninety-Six and 21/100's Dollars (\$9,369.21) of warrants with corresponding interest of Two Hundred Thirty-Three and 61/100's (\$233.61).

BE IT FURTHER RESOLVED, that the Board of Trustees of Sanitary and Improvement District No. 7 of Platte County, Nebraska, approve the redemption of **Construction Fund #2** Warrant Nos. 55-58 as of October 31, 2019 in Twenty Thousand and 00/100's Dollars (\$20,000.00) of warrants with corresponding interest of Five Hundred Four and 12/100's (\$504.12).

BE IT FURTHER RESOLVED, that the Board of Trustees of Sanitary and Improvement District No. 7 of Platte County, Nebraska, approve the redemption of 7th **Subdivision** Warrant Nos. 60-63 as of October 31, 2019 in Twenty Thousand and 00/100's Dollars (\$20,000.00) of warrants with corresponding interest of Five Hundred Four and 12/100's (\$504.12).

On roll call for the foregoing resolutions, the following Trustees voted Aye: Rongisch, Marxsen, Stevens, Goc, and Boesch. Voting Nay thereon were the following Trustees: None. The Chairman then declared said resolution was duly carried and adopted.

The Chairman then directed the Board's attention to Item No. 5 on the agenda, pertaining to discussion and review of bids to tar street cracks. The District received two bids to tar street cracks. Bader's Highway & Street quoted the District \$8,942.00. Gehring Construction quoted the District \$15,640.00. The Board decided to table the decision of which contractor to use until Spring/Summer 2020 due to the start of levee erosion project.

The Chairman then directed the Board's attention to Item No. 6 on the agenda, pertaining to payment of outstanding bills on file and bills presented during the meeting. After a full discussion, the following resolutions were moved by Trustee Stevens and seconded by Trustee Marxsen, to-wit:

BE IT RESOLVED, that the Board of Trustees of Sanitary and Improvement District No. 7 of Platte County, Nebraska, that the Chairman and Clerk be, and they hereby are, authorized and directed to execute and deliver **General Fund** Warrant Nos. 515-519 dated today's date, to the following payees and in the following amounts:

- A. General Fund Warrant No. 515 in the sum of Thirty-Four and 84/100's Dollars (\$34.84), payable to Columbus Telegram for payment of advertising services.
- B. General Fund Warrant No. 516 in the sum of Nine and 16/100's Dollars (\$9.16) payable to Columbus Telegram for payment of advertising services.
- C. General Fund Warrant No. 517 in the sum of One Thousand Two Hundred Ninety-Seven and 82/100's Dollars (\$1,297.82) payable to LARM for payment of insurance services.
- D. General Fund Warrant No. 518 in the sum of Three Thousand and 00/100's Dollars (\$3,000.00) payable to Advanced Consulting Engineering Services for payment of levee construction services.
- E. General Fund Warrant No. 519 in the sum of Seventy and 00/100's Dollars (\$70.00) payable to Rogan Goc for payment of mowing services.



There being no further business to come before the meeting, a motion for adjournment was duly moved by Trustee Boesch and seconded by Trustee Goc, and unanimously carried. The meeting was adjourned at 10:19 a.m.





Advance notice for the Meeting was given by publication as set forth in the affidavit of publication contained in the foregoing transcript and was mailed to the Clerk of the municipality or county within whose zoning jurisdiction the District is located at least seven days prior to the date of the Meeting. Advance notice for the Meeting, including notice of agenda subjects, was given to all members of the Board of Trustees. All news media requesting notification of meetings were provided with advance notice of the times and places of such meetings and the subjects to be discussed.

All of the subjects addressed at the Meeting were contained in the agenda for the Meeting, which agenda was kept continually current and readily available for public inspection at the address listed in the meeting notice for the Meeting and a copy of which is attached to this Certificate; such subjects were contained in said agenda for at least 24 hours prior to the Meeting and each agenda item was sufficiently descriptive to give the public reasonable notice of the matters to be considered at the Meeting.

A current copy of the Nebraska Open Meetings Act was available and accessible to members of the public, posed during the Meeting in the room in which such Meeting was held and all in attendance at the Meeting were informed that such copy of the Nebraska Open Meetings Act was available for review and were informed of the location of such copy in the room in which such Meeting was being held. At least one copy of all resolutions and other reproducible written materials, for which actions are shown in said proceedings, was made available for examination and copying by members of the public at the Meeting.

collection of tax or other revenues or relating to any of the improvements for which any such warrants or other obligations were or are issued nor in any manner questioning the proceedings and authority under which any such warrants or other obligations were or are issued or affecting the validity thereof; neither the corporate existence or boundaries of the District nor the title of its present officers to their respective offices is being contested; no authority or proceedings for the issuance of any warrants or other obligations by the District have been repealed, revoked or rescinded as of the date hereof. All actions taken by the Board of Trustees referred to in said transcript were taken at a public meeting while open to the attendance of the public.
