A meeting of the Board of Trustees of Sanitary and Improvement District No. 7 of Platte County, Nebraska, was convened in accordance with Executive Order No. 20-03 at 9:00 a.m. on Thursday, January 21, 2021, at the Columbus Housing Authority-Community Room, 2554 40th Avenue, Columbus, Nebraska. Trustees present at the meeting were: Doug Brackhan, Tom Goc, Jay Marxsen, Roger Seefeld, and Jerry Slusarski. Trustees Absent: None. Other interested parties present: Jenny Reppert, Platte County Treasurer; Adam Elm, Accountant for Schumacher, Smejkal, Herley & Elm, P.C.; Craig Jones, First National Capital Markets, Inc. Representative; Mark Fitzgerald, Attorney for Fitzgerald, Vetter, Temple, Bartell & Henderson; Shelia Cermak; Bill Rongisch; Lance Lehr; Jeff Lehr; Barb Lehr; and Nicki Lehr.

Notice of the meeting was given in advance thereof by publication in the *Columbus Telegram* on January 15, 2021, a copy of the Proof of Publication being attached to these minutes. The availability of the Agenda was communicated in the published notice and in the Notice to the Trustees of this meeting. All of the subjects addressed at this meeting were contained in the Agenda for at least 24 hours prior to the meeting, which Agenda was kept continually current and readily available for public inspection at the address listed in the meeting notice. All proceedings of the Board were taken while the convened meeting was open to the attendance of the public. A current copy of the Nebraska Open Meetings Act was available and accessible to members of the public, posted during the meeting in the meeting area and all in attendance at the meeting were informed of the location of such copy. At least one copy of all resolutions and other reproducible written materials, for which actions are shown in said proceedings, was made available for examination and copying by members of the public at the meeting.

Following roll call, the Chairman directed the Board's attention to Item No. 2 on the agenda, pertaining to discussion and approval of the November 6, 2020 meeting minutes. After a full discussion, the following resolution was moved by Trustee Goc and seconded by Trustee Marxsen, to-wit:

BE IT RESOLVED, that the Board of Trustees of Sanitary and Improvement District No. 7 of Platte County, Nebraska approve the November 6, 2020 meeting minutes.

On roll call for the foregoing resolution, the following Trustees voted Aye: Brackhan, Goc, Marxsen, Seefeld, and Slusarski. Voting Nay thereon were the following Trustees: None. The Chairman then declared said resolution was duly carried and adopted.

The Chairman then directed the Board's attention to Item No. 3 on the agenda, pertaining to discussion and financial review of the District's accounts. Discussion was held regarding the financial state of the District. No action was taken at this time.

The Chairman then directed the Board's attention to Item No. 4 on the agenda, pertaining to discussion of Lance Lehr's request for detachment from the District. The attorney for the District discussed with the Board the process of detachment of property within the District and summarized part of the statutory process for detachment from an SID. Part of the Statute permits an owner to petition the Board

to have the owner's property detached from the District. At the hearing for consideration of such a resolution, the Board is to determine if the land proposed for detachment: 1) has an area of 25 acres or more; 2) is wholly detached from the main area of the SID and separated from the SID by a distance of at least 1,000 feet at the nearest points; 3) is undeveloped and predominately devoted to agriculture; and 4) has no improvements placed on it by the SID and the property receives no current services from the District. The attorney indicated that the Lehr property in question here does not qualify. The other way to detach is by a resolution of the Board of Trustees. The Trustees propose a resolution declaring the advisability of such detachment and setting out in verbatim the terms and conditions thereof and also setting out the time and place when the Board will meet to consider adoption of the resolution. Notice of the time and place when the resolution is set for consideration is to be published. The City of Columbus is entitled to notice. The attorney read from the Statute:

If the owners representing a majority of the area of real estate within the district fail to sign and present to the board of trustees or the administrator, on or prior to the hearing date, a written petition opposing the resolution, then a majority of the board of trustees or the administrator may pass the resolution and thereby adopt the proposed detachment, except that no such resolution shall be adopted if the district is then indebted on any outstanding bonds or warrants of the district unless the holders of such bonds and warrants shall sign written consents to the detachment prior to the adoption of the resolution of detachment.

The attorney indicated to the Board that the creditors of the District had a right to essentially veto the detachment resolution. After a full discussion, the following resolution was moved by Trustee Goc and seconded by Trustee Brackhan, to-wit:

BE IT RESOLVED, that the Board of Trustees of Sanitary and Improvement District No. 7 of Platte County, Nebraska approve the attorney for the District investigate the detachment process further including contacting creditors in order to prepare a proposed resolution for the Board to consider at its next meeting.

There followed a discussion concerning reimbursement for costs.

The Board of Trustees of Sanitary and Improvement District No. 7 of Platte County, Nebraska indicated that the motion should be amended to include reimbursement for all costs, including attorney fees, from this point forward, by the property owners. Both the moving party and the Trustee making the second agreed to this amendment. Representatives attending from the Lehr group also agreed to this resolution.

On roll call for the foregoing resolution, the following Trustees voted Aye: Brackhan, Goc, Marxsen, Seefeld, and Slusarski. Voting Nay thereon were the following Trustees: None. The Chairman then declared said resolution was duly carried and adopted.

Lance Lehr, Jeff Lehr, Barb Lehr, Nicki Lehr, and Shelia Cermak left the meeting at 10:00 a.m.

BE IT RESOLVED, that the Board of Trustees of Sanitary and Improvement District No. 7 of Platte County, Nebraska approve tabling the decision to refinance the District's debt until the next meeting.

On roll call for the foregoing resolution, the following Trustees voted Aye: Brackhan, Goc, Marxsen, Seefeld, and Slusarski. Voting Nay thereon were the following Trustees: None. The Chairman then declared said resolution was duly carried and adopted.

The Chairman then directed the Board's attention to Item No. 6 on the agenda, pertaining to the discussion and hiring of Johnson Trucking to provide snow removal services for the District. After a full discussion, the following resolution was moved by Trustee Goc and seconded by Trustee Seefeld, to-wit:

BE IT RESOLVED, that the Board of Trustees of Sanitary and Improvement District No. 7 of Platte County, Nebraska approve hiring Johnson Trucking to provide the District with snow removal services.

On roll call for the foregoing resolution, the following Trustees voted Aye: Brackhan, Goc, Marxsen, Seefeld, and Slusarski. Voting Nay thereon were the following Trustees: None. The Chairman then declared said resolution was duly carried and adopted.

The Chairman then directed the Board's attention to Item No. 9 on the agenda, pertaining to discussion of the District's status with FEMA/NEMA. Bill Rongisch was present to update the Board on the project with FEMA/NEMA. No action was taken at this time.
